The trial is specifically for breeds from the Working group only. They qualified in Grad Novice, taking 1st place both days. They also competed in Rally Advanced B class, qualifying both days and taking 3rd on Sunday. Rumble was also the high scoring BMD on Sunday. (and yes, there was more than one BMD)

Carol Manley is proud to announce that her boy **Rumble** has earned the award of Top Scoring Novice B Bernese Mountain Dog for 2010. This award is given by the National BMD club and based on the average of Rumble's first 3 qualifying scores in Novice B competition. Rumble's scores were 195, 195 and 196.5, giving him an average of 195.5.

Deb Leimbek and **Lacey** (Labrador): Reserve on Saturday & BOB on Sunday in Jordan TC Labrador Specialty on Friday, Jan 7th Winners bitch and an Award of Merit 3pt major in St. Paul. Finishing on Sunday with Winners bitch (3 pt major) for Lacey's AKC champion title.

Roger Peterson & OTCH Wildrose Roja's Kihei UDX3 OM5 RN SHR UH; Getting an "Obedience Trial Champion" title on Kihei was a fun and rewarding challenge. We learned a lot and certainly found out why they call it campaigning. To get an "OTCH" you must get 100 "OTCH" points and have at least 3 first places (1 each in utility & open). The points are awarded for placing according to the number of dogs

showing. What separates an "OTCH" from the other titles is that you must win not just qualify. Winning in the Midwest can be daunting to say the least, many of the trials have 4 or 5 of the best dogs in the country competing, plus maybe 10 others good enough to step up. When we went to St. Paul's River Center Jan. 8th & 9th, Kihei only needed 6 more points so I thought we could just ease out. Kihei decided to go in style with a 199 in Open B for first place and "High in Trial", making it one of the most exciting days of my life.

Dianna Anderson and her Bearded Collie, **River**, attended the Minnesota Agility Club USDAA agility trial February 19th-20th in Cannon Falls, MN. River finished his Starters Relay Pairs (SR) title at the trial.

On January 8th, at the Land O' Lakes Kennel Club show, **Wanda & Luca**

took first in Amateur Owner Dogs. Then in his specialty show sponsored by the Twin Cities German Wirehaired Pointer Club, he won Field Trial Dog and competed in best of breed for the specialty. His whole name is Intl. Ch. Alison's Luca Von Blackforest CGC, JH, RN, CD, NAVHDANA Prize 1-112.

Deb Steen & Bug entered their first CPE Agility trial put on by On the Run 11/27 & 11/28. In Standard Level 1, Bug had a qualifying run with 4th place. Snooker and Jumpers (Level 1) were both Qs and First place.
